SHORT CIRCUITS

NOTICE FROM THE VIRGINIA BEACH CIRCUIT COURT REGARDING DIVORCE AND DOMESTIC RELATIONS CASES

As a result of a meeting with the domestic relations bar, and after discussion by the judges as a group, the court restates and/or amends the following policies:

• Friday "contested" divorce docket and in-home separation cases: the court will schedule up to four of these types of divorces in available one hour Friday Contested Divorce Docket slots.

• Scheduling domestic relations cases on the duty docket: If it is a pendente lite hearing, if both counsel write to the Chief Judge and ask that the matter be set on the duty docket, it can be approved for up to a two hour hearing. For other domestic relations issues, if both sides agree, any judge can approve setting the matter on the duty docket for up to two hours.

• Issues with availability of judicial settlement conference judges: the judges have been made aware that there is limited availability of settlement conference judges so that scheduling a settlement conference is difficult. The court will be more sensitive to the necessity of settlement conferences so as to not delay trials.

• Assignment of complex equitable distribution cases: the court will continue the practice of assigning these upon request by both parties made to the Chief Judge.

• Issues with final decrees being returned for limited corrections without being reviewed in their entirety by the law clerks ("not otherwise reviewed"): this only occurs in particular situations, and the court will continue to monitor this.

• Issues with requiring service of amended complaints: if the original complaint states grounds, any amendments will not have to be re-served.

Reminder: As stated in the court's Contested Divorce Procedures Manual, the Virginia Beach Divorce Pretrial Order is required for use in contested divorces. Only that order should be submitted, not the Uniform Pretrial Scheduling Order (which is for general civil ^{matters}, not divorces), or both pretrial orders.



NOTICE FROM HON. ROBERT G. MACDONALD, CHIEF JUDGE, Chesapeake general district court issuance of Subpoenas in automobile accident cases

In automobile accident cases, many attorneys and defendants appear on the first return date merely to set a date for trial, so that the witnesses/victims can be subpoenaed to appear. Concerns have been raised by the Bar, as well as defendants, on our current procedure. In response to the concerns, the Court is modifying the procedure relating to traffic summonses involving an automobile accident.

The following procedure will be effective on January 1, 2020:

When an officer issues a summons at the scene of accident, they will subpoen any necessary witness to appear in court at the same time. The officer will provide the defendant with a copy of DC-217, VIRGINIA PREPAYABLE OFFENSES INFORMATION SHEET. The DC-217 contains language advising the defendant, "If you were involved in an accident and desire to plead NOT GUILTY and have your case heard on the date set, please notify the court by checking the not guilty box and return this form to the court within 7 calendar days..." For those defendants who notify the court and do not request a continuance, the case can be heard on the original trial date. For those defendants who do not notify and simply appear in court, the case can proceed on the original trial date. Only in those instances where the defendant wishes to plead not guilty and wishes to change the date will the witnesses have to be called off and resubpoenaed.

VBSO ANNOUNCES UNIVERSAL SECURITY Screening for Virginia Beach Courthouse

In an effort to improve public safety, the Virginia Beach Sheriff's Office is implementing universal security screening for all persons entering the Virginia Beach Courthouse effective Monday, Aug. 12, 2019. Only sworn public safety officers on official business will be exempt from screening. All other persons – including attorneys and civilian employees assigned to work inside the Courthouse – will be required to be screened.

The change is as a result of ongoing efforts to improve security at the Courthouse, which is one of the most heavily trafficked public buildings in the city. Security enhancements have been ongoing since the Sheriff's Office conducted an extensive threat assessment of the building in 2017, followed by a subsequent security review in February 2019.

"Public safety is our first priority at the Virginia Beach Sheriff's Office," said Sheriff Ken Stolle. "We understand that this change may be inconvenient, but we have to prioritize safety above convenience. We must also be proactive and ever-vigilant in fulfilling our obligation to safeguard the hundreds of people who come into the Courthouse every day."

Security staffing will be increased to facilitate the additional screenings. However, members of the public should give themselves additional time to get through security when reporting for a court hearing or other time-sensitive matter. Everyone entering the Courthouse will be searched with a magnetometer and their belongings screened by an X-ray machine. As always, weapons (including knives and firearms), large liquids (with the exception of baby formula and small items such as hand sanitizers) and electronic devices (including cellphones) are prohibited inside the Courthouse. Public safety officers, attorneys, reporters and employees with required credentials will still be permitted to bring their cellphones, laptops, etc. into the building. Security personnel retain the right to prohibit any item they deem a potential threat to public safety.

"We will do everything we can to make our enhanced security screening process as efficient as possible," said Chief Deputy Rocky Holcomb. "You can help by giving yourself some extra time, leaving unnecessary items at home and being prepared to be searched. We appreciate everyone's patience and understanding as we work to make the Courthouse as safe as it can be."
