

SHORT CIRCUITS

PRACTICE TIPS FROM THE CIRCUIT COURT

SELECTED STATUTORY CHANGES THAT ARE EFFECTIVE JULY 1

While the support notices for domestic relations matters weren't altered this year (whew!), there were many other changes that can affect your practice in domestic relations and otherwise. Here are a few:

FEDERAL CIVILIAN EMPLOYEES NOW COVERED BY § 20-97(3)

Section 20-97 sets forth subject matter jurisdiction requirements for annulments and divorces. Subsection (3) enables those who are currently stationed overseas to be able to file for divorce in Virginia, so long as the person was domiciled here for the six-month period immediately preceding their departure. Previously, this section covered only military members and foreign service officers, but effective July 1 federal civilian employees can also make use of this provision.

DRIVER'S LICENSE NO LONGER AUTOMATICALLY SUSPENDED IF A GUARDIAN OR CONSERVATOR IS APPOINTED

In what has sometimes been a trap for the unwary, § 46.2-400 has traditionally provided that if a guardian or conservator is appointed, the person subject to the appointment "shall" have his or her license suspended. Because this provision is not located in the guardian/conservator appointment statutes, sometimes licenses ended up being unintentionally suspended. It will now be even more important to be aware of this code section, because as of July 1 there will be a way out of that problem. New § 46.2-400(B) provides that the license shall not be suspended "where the court order specifically permits such person to retain his driver's license or the privilege to drive or to apply for such license." In that instance, the order is not to be sent to the DMV – so if you take advantage of § 46.2-400(B) be sure you remove any language requiring that from your order. The prior automatic suspension rule still applies if the order is silent on this issue. Also, the statute gives the court the power to order the incapacitated person to be evaluated by the DMV on his or her fitness to drive. Exercise of that power is something that is likely to occur in almost any situation where the order appointing a guardian or conservator seeks to avoid suspension of the driver's license of an incapacitated person.

CUSTODY/VISITATION ORDERS THAT PROHIBIT A PARTY FROM PICKING UP A CHILD FROM SCHOOL MUST BE SENT TO THE SCHOOL

Sections 16.1-278.15 and 20-124.2 have had subsections added ((J) and (F), respectively) that require the court to order one of the parties to provide a copy of the order to the school where the child is enrolled. This must be done within three business days after that party receives the order. As a backup, the court can mail the order to the school if it determines that the party is unable to deliver the order. However, that party must provide the court with the name of the principal and address of the school.

CHILD SUPPORT CAN ORDERED PAID INTO A SPECIAL NEEDS TRUST OR ABLE ACCOUNT

Sections 16.1-278.15(A) and 20-124.2(C) have been amended to permit payment of child support for a disabled child into a special needs trust or ABLE account. This will add more flexibility to how funds for disabled children can be used.

PRE-SUIT DISCLOSURE OF LIABILITY POLICY LIMITS

New § 8.01-417.01 gives one the right to disclosure of homeowner's insurance liability limits for injuries suffered at a residence before suit is filed, if certain conditions are met. This is similar to legislation previously adopted for automobile liability insurance.

CLARIFICATION OF WHO MUST GIVE NOTICE OF AN ADOPTION PLAN AND ABILITY TO REGISTER WITH THE VIRGINIA BIRTH FATHER REGISTRY (FORMERLY PUTATIVE FATHER REGISTRY)

For the last ten years, § 63.2-1250 has required that a birth father be given notice of a planned adoption and his right to register with the registry, under certain circumstances. However, the statute has never identified who is required to give the notice. Effective July 1, subsection F will now specify that if required, this notice must be given by "the child-placing agency or the adoptive parents."

2017 GENERAL DISTRICT COURT HOLIDAY LEAVE SCHEDULE

The Committee on District Courts has the authority to determine when the district courts and clerks' offices of the Commonwealth shall be open for business, and the Judicial Council has the authority to determine when the circuit courts (excluding circuit court clerks' offices) shall be open for business. Va. Code §§ 16.1-69.33, 17.1-705.2. Both judicial policy-making bodies met last week and authorized the holiday schedule below for their respective levels of court.

Monday, July 3: closed (This is an additional day off approved by Judicial Council and Committee on District Courts.)

Tuesday, July 4: closed

ORDER CONCERNING COMPLAINTS FOR AND FINAL DECREES OF DIVORCE IN NORFOLK VIRGINIA: IN THE CIRCUIT COURT OF THE CITY OF NORFOLK

Venue in suits for divorce is "preferred" and governed by Code of Virginia § 8.01-261(19), which provides that venue is proper where the defendant resides or where the parties last cohabited, or, if the defendant is not a resident of Virginia, where the plaintiff resides. Venue in divorce cases is no longer jurisdictional, nor is it mandatory, and if the defendant does not object, the suit can be filed and litigated in any jurisdiction within the Commonwealth. However, Code of Virginia § 8.01-264(D) authorizes the Court, within sixty days of service of process on all parties, sua sponte, to transfer a divorce cause filed in an improper venue to a proper venue. The Judges of this Court, to date, have exercised this authority infrequently.

In calendar year 2016, 3,963 complaints for divorce were filed in this Court. Based upon data supplied by the Supreme Court of Virginia, this constituted approximately 12% of all complaints for divorce filed in 2016 throughout all Circuit Courts in Virginia. For several years, residents of other cities in Hampton Roads have filed many contested divorce suits in Norfolk and residents of other areas of the Commonwealth have filed thousands of uncontested divorce cases in this Court. A conservative estimate is that venue is improper in 75% of all divorce suits filed in this Court. During 2016, the following numbers of complaints for divorce were filed in the Circuit Courts of our neighboring cities: Chesapeake — 1,009; Virginia Beach — 1,147; Portsmouth - 363; Suffolk — 273; Hampton — 548; Newport News — 680.


The Court and the Clerk appreciate the confidence the Bar and the public have shown in our practice of concluding suits for divorce promptly, but the disproportionate number of divorce filings in this Court is not consistent with the intent of Code of Virginia § 8.01-261(19).

Many divorce complaints filed in this Court do not state the residences of the parties or the place they last cohabited, rendering it difficult for this Court to exercise its discretionary statutory authority to transfer the cause to a proper forum.

Therefore, with unanimous consent of the Judges of this Court, it is ORDERED that effective June 1, 2017, all complaints for divorce filed in this Court, whether by counsel or the plaintiff pro se, shall state within the style or body thereof or include a separate paper stating the city and/or county and state of residence of the plaintiff and the defendant, or, if the residence of the defendant is unknown, the city and/or county and state where the defendant was last known to reside, and the city and/or county and state where the parties last cohabited.

FURTHERMORE, as it would be a burden to the docket should this Court become the forum for post-divorce litigation when neither party lives in the City of Norfolk, and as we wish to exercise in full our authority under Code of Virginia § 20-107.3(L), it is therefore ORDERED that every final decree of divorce tendered to this Court on or after June 1, 2017, which awards equitable distribution or incorporates a separation agreement, and which does not include a transfer provision pursuant to Code of Virginia § 20-107.3(L), shall state the city and/or county and state where each party then resides.

THE Clerk shall post a copy of this order on his web site, and mail copies to the Director of the Norfolk-Portsmouth Bar Association, the Portsmouth Bar Association, the Virginia Beach Bar Association, and the Chesapeake Bar Association.
