### MENTAL HEALTH DOCKET REFERRAL FORM

The Honorable Gene A. Woolard, Chief Judge of the General District Court, is pleased to announce the formation of a mental health docket to be held on the 1st and 3rd Tuesday of every month at 2:30 p.m. The first docket will be held on May 5, 2015, in the Criminal Court. This is a collaborative effort of the Court, the Sheriff's Department, the Police Department's Crisis Intervention Team, the Commonwealth's Attorney's Office, the Public Defender's Office, the Virginia Beach Bar Association, the Department of Health and Human Services, the Community Corrections Program, and the VA Hospital.

Its mission is to better expedite those cases involving defendants with potential mental health issues and have them screened for competency to stand trial and/or sanity at the time of the offense, and then track those cases more closely to ensure that incompetent defendants are either timely transferred to a state hospital, restored to competency locally in the Virginia Beach Correctional Center, or returned to the regular docket if found to be competent by Dr. Keenan. This program has been successful in neighboring jurisdictions in reducing the wait times spent by incompetent defendants seeking restoration by approximately 50 percent. It will also give the judges a mechanism by which to better track defendants with known mental health issues who recurrently show up on the Court's docket.

If you have identified a client as having a mental health issue whose competency may be in question, all you have to do to have your client added to the next mental health docket is complete the Mental Health Docket Referral Form and fax it to the Criminal Court Clerk's Office at (757) 385-1065, attention Jude Jackson. Jude will be coordinating the logistics of the mental health docket and her telephone number is (757) 385-8783. Once added to the docket, you will be expected to attend the hearing and make any appropriate motions on behalf of your client with all of the aforementioned parties present and available to give input on available services. Orders can be entered and distributed at the hearing, if appropriate. If you are a private attorney who has been court-appointed or retained to represent a defendant with a potential competency issue and have questions about the process, the Virginia Beach Bar Association's liaison to the Court is Tim Quick and he can be reached at (757) 716-3700 or tim@quicklegal.net.

Please note the following prior to your submission for this appointment:

- Applicants must be a member of the Virginia State Bar in good standing with a minimum of 5 years in practice.
- Applicants must be a resident within the boundaries of the Second Judicial District, City of Virginia Beach.
- Appointees must be willing and routinely available to sit in both the General District Court and the Juvenile and Domestic Relations District Court.
- Substitute Judges are appointed to serve for a term of six years.
- Prior to an appointment as a Substitute Judge, appointees must submit fingerprints to be used for the conduct of a national criminal records search and a Virginia criminal history records search.

All submissions received on or before June 30, 2015, will be given consideration for appointment.



Practice tips from the Circuit Court

SELECT LEGISLATIVE CHANGES EFFECTIVE JULY 1

## § 20-60.3 HAS BEEN AMENDED

Unfortunately, after a number of years without change, § 20-60.3 has some new provisions added effective July 1. Subsection 5 has provisions added to give notice of the right to petition for child support for a disabled child over the age of 18, even if no support was previously requested. The only additional requirement is that the disability existed before the child reached the age of 18. Please update your decrees and orders accordingly!

### **CHANGES TO ADOPTION LAWS**

New subsection D has been added to § 63.2-1232, concerning acceptance of consent for parental placement adoptions. It allows the juvenile and domestic relations court to waive the requirement of a home study, as well as counseling of the prospective adoptive parents, when the adoptive parents have had continuous custody of the child for at least five years.

# NEW STATUTE OF LIMITATIONS FOR SOME FORMS OF INTERNET DEFAMATION

Section 8.01-247.1, which sets forth the statute of limitations for defamation, will now have a new discovery-based provision for internet defamation. If the defamation is anonymously posted or posted using a false name, the limitations period will be tolled until the plaintiff discovers, or reasonably should have discovered, the identity of the poster.

# **AMENDMENTS TO § 20-97 AND § 20-106**

Both of these sections have been amended to change references from "commencement of the suit" to "the filing of the suit." New subsection C has been added to § 20-106 to allow parties to proceed by affidavit based upon a § 20-121.02 motion (to change from fault to no-fault grounds). Since the Virginia Beach Circuit Court has already been operating on that basis, the amendment will not change the court's procedures. Finally, § 20-106 will now allow affidavits from more than one corroborating witness. The corroborating witness(es) will be permitted to corroborate that either party had the intent to remain permanently separated, rather than being limited to the intent of the moving party.

Some of these amendments will require changes to the court's affidavit/uncontested divorce questions. Be sure to check the Uncontested Divorce Procedures Manual for the updated version, which hopefully will be posted a couple of weeks before July 1.

# AFFIDAVITS NOW EXPRESSLY PERMITTED IN SUPPORT OR OPPOSITION TO A TEMPORARY INJUNCTION

Section 8.01-628 previously referred to the use of an affidavit only in support of an injunction, and then only by reference in its title or headline. Since affidavits were only mentioned in the title, their use was not technically included in the code section. The body of § 8.01-628 now has been amended to permit the use of affidavits, and permitting them in opposition to a temporary injunction has been added.




