

PRESIDENT'S MESSAGE

Now that the world is firmly in the Covid-19 era, members of the bar have had their lives radically changed by being tasked with mastering remote learning for our children, managing remote hearings for our vocation, wearing masks in public for our appearances, and dealing with uncharted waters concerning how juries are going to be impaneled. If members of the bar were told last year that they would have to conform to working remotely, homeschooling their children, and continuing every case from March 16, 2020, to after July 19, 2020, one would wonder how life as we know it would go on.

Somehow members of the bar have managed to come together and limp through these trying times. Remote depositions are a necessity with the Supreme Court of Virginia approving and encouraging remote audio/video depositions. The Virginia Beach Courts routinely update their Covid-19 Orders immediately and often send them to the VBBA for publishing to our members. The VBBA has moved into the Covid-19 era utilizing webinars to provide continuing education for its members. Finally, most of our members and clients seem to be getting used to wearing a mask or face covering while in court or at an in-person meeting.

On a positive note, we, as members of the bar, have been forced out of our comfort zones to utilize technology. We can now participate in continuing legal education from the comfort of our home office and not have to worry about finding a parking space at Elevation or MOCA. Some hearings are being conducted by audio/video conferencing, such as infant settlements and other routine hearings, where an in-person appearance may not be a necessity. These adaptations will make us more efficient in the post-Covid-19 future.

Of course, there have been tremendous negative effects. The widespread continuance of cases has stymied the most seasoned of paralegals, frustrated plaintiffs and defendants, and has had an adverse financial impact upon plaintiffs, defendants, and attorneys.

What consequences has Covid-19 had on the local judicial system? American author Dan Millman wrote in his book, *Way of the Peaceful Warrior*, "The secret of change is to focus all of your energy not on fighting the old, but on building the new." The full consequences of Covid-19 on the judicial system are yet to be determined, but one certainty is that



The list includes the following:

1. Virginia Beach Drug Treatment Court: This program is administered by the Virginia Beach Commonwealth's Attorney's Office, Probation and Parole, Department of Human Services, and the Virginia Beach Circuit Court. The goal of the Virginia Beach Drug Treatment Court is to rehabilitate nonviolent drug offenders and addicts and provide them with an alternative to prison in order to change their long-term behavior. Contributions provide assistance with graduation costs and expenses associated with providing recognition of graduates from the program, which are not funded by the state or city.
2. Legal Aid Society of Eastern Virginia: Legal Aid Society of Eastern Virginia is a nonprofit that provides representation in civil matters to low income residents of Hampton Roads. It has an office in Virginia Beach. It provides free legal services in civil matters to qualifying low income people in furtherance of its mission to promote the equal application of justice and to remove impediments to fairness for low income and vulnerable families of eastern Virginia.
3. Virginia Beach CASA: Court Appointed Special Advocates ("CASA") for children is a community-based program that recruits, trains and supports citizen-volunteers to advocate for the best interests of abused and neglected children in the courtroom. The Virginia Beach CASA program has existed since 1989.
4. First Colonial Legal Studies Academy: The Legal Studies Academy at First Colonial High School provides students who have an interest in the law, law related fields, and legal and ethical issues the opportunity to extend their knowledge beyond the typical high school program. The Academy offers students the opportunity to explore careers in the area of legal studies in its four-year program.
5. Connect With A Wish: Connect With A Wish, Inc. is a nonprofit organization operating in Virginia Beach that assists children in Virginia Beach foster care with resources and support needed to grow into positive and productive members of the community. Its efforts include court-related activities and helping with the legal needs of children in foster care.
6. Virginia Beach High School Mock Trial Program: The Virginia Beach High School Mock Trial Championship Program is currently operational at Kellam High School, First Colonial High School, and Cape Henry Collegiate. It is designed to promote an understanding and appreciation of the American judicial system through academic competitions and other endeavors for high school students.
7. Paralegal Certification Program Scholarships: Needy students wishing to enroll in paralegal training programs often need financial assistance. Through scholarships funded by the VBBF, we would help to expand these opportunities to more residents of Virginia Beach.
8. Law School/College Scholarships: Law foundations have historically provided scholarships to qualified applicants needing financial assistance when entering law schools or pre-law college programs.
9. Wills for Heroes Foundation: Wills for Heroes is a program that provides free estate planning documents for first responders. It was implemented shortly after the September 11, 2001 terrorist attacks.

NOTICE OF NEW DOCKET TIMES FOR CITY OF VIRGINIA BEACH GENERAL DISTRICT COURT

In order for the Court to continue to process its cases in an efficient and timely manner, as well as to assure compliance with current and future public safety mandates, changes have been made to various docket times in the Court's divisions. The new docket times are as follows:

CIVIL COURTROOM A: Beginning July 1, 2020, first returns on cases will be heard Monday through Friday at 8:30, 9:30, 10:30, and 11:30 a.m. Uncontested cases will be resolved on the initial return date. Contested cases will be set for a future date on Mondays, Wednesdays and Thursdays at 9:30 a.m. in Civil B. Current high-volume filers have been assigned specific days and times to schedule their cases. Any attorneys filing in Civil A that do not have an assigned day and time should file on their preferred day at 8:30 a.m. Any high-volume filers without an assigned day and time must contact the clerk's office before filing so that an available day and time can be assigned. Attorneys filing in Civil A will be limited to 100 general filings (warrants in debt and detinue, etc.) and 75 garnishments per assigned day and time.

CIVIL COURTROOM B: Beginning August 1, 2020, first returns on warrants, notices of motions for judgment, and garnishments will be heard on Mondays, Wednesdays and Thursdays at 8:30 a.m. Uncontested matters will be resolved on the initial return date. Contested matters will be scheduled for a future date on Mondays, Wednesdays and Thursdays at 9:30 a.m. Unlawful detainers will be heard on Tuesdays and the first and third Friday of every month at 8:30 a.m. Small claims cases will continue to be heard on the second Friday of the month at 8:30 a.m.

TRAFFIC COURTROOMS A AND B: Beginning August 1, 2020, cases will be heard daily at 8:30 a.m., 9:30 a.m., 11:00 a.m., and 12:00 p.m. Some law enforcement agencies have begun writing warrants and summonses for return dates in July 2020 with these new docket times. These cases will be heard at the time specified on the charging document.

No changes have been made to the docket times for Criminal Courtrooms 1 and 2, or for Traffic Courtroom C. Cases in Criminal Courtrooms 1 and 2 will continue to be heard daily at 8:30 a.m., 11:00 a.m., and 2:00 p.m. Cases in Traffic Courtroom C will continue to be heard daily at 8:30 and 11:00 a.m. As of July 1, 2020, ASAP violations will be heard Monday through Wednesday at 11:00 a.m. in Traffic C.

No changes have been made to the schedule for bond hearings or arraignments. Felony bond hearings are heard daily at 8:00 a.m. in Traffic Courtroom D. Misdemeanor bond hearings are heard daily in the courtroom in which the trial is scheduled and at the time scheduled for trial. In-custody arraignments are heard in Traffic Courtroom D at 2:00 p.m. **

(**During the current period of judicial emergency ending June 28, 2020, felony bond hearings are at 8:00 a.m., misdemeanor bond hearings are at 9:00 a.m., and in-custody arraignments are at 1:00 p.m. All in Traffic Courtroom D.)


