

Determination of Counsel / First Appearance Hearings for DUI's in Traffic Courtroom C

Beginning December 1, 2021, the determination of counsel / first appearance hearings for DUI's set in Traffic Courtroom C will be moving from 8:30 a.m. to 8:00 a.m. and will be handled in the same manner as the Court handles them for felonies.

VIRGINIA BEACH GENERAL DISTRICT COURT CIVIL DIVISION UPDATES

Effective November 1st, 2021 clerk's office should charge \$24 total for service for a garnishment of a single debtor (\$12 for service of the garnishment on the debtor and \$12 for service on the third-party garnishee). The clerk's office should charge \$12 total for service of an interrogatories (\$12 service on the debtor only). The court should no longer charge a separate service fee for the writ of fieri facias portion, even if the request for the writ of fieri facias is completed on the form, as service for the writ of fieri facias is incorporated within the sheriff's fees for service of the garnishment summons/interrogatories.

The court requests that if attachments to a case are added the day of court that they be paperclipped or tabbed. It will alert the Clerk's Office that new information is included in the case and needs to be scanned. This will assist the Clerk's Office in complying with its scanning requirements and make the information more accessible to your office. Scanning will continue to play an increasing role in the development of future technologies for the court and we appreciate your assistance with helping us meet our goals.

NOTICE OF CHANGES TO DOCKET TIMES IN CIVIL COURTROOM B AND TRAFFIC COURTROOMS A, B AND C FOR VIRGINIA BEACH GENERAL DISTRICT COURT

Civil Courtroom B:

Beginning January 1, 2022 first returns on warrants, notices of motions for judgment, and garnishments will be heard on Mondays, Wednesdays, Thursdays, and Fridays at 8:30 a.m. Uncontested matters will be resolved on the initial return date. Contested matters will be scheduled for a future date on Mondays, Wednesdays, Thursdays, and Fridays at 9:30 a.m. Unlawful detainers and tenants' assertions will be heard on Tuesdays only. Small claims cases will continue to be heard on the second Friday of the month at 8:30 a.m.

Traffic Courtrooms A and B:

Effective immediately, traffic cases will be returning to the pre-pandemic times of 8:30 a.m. and 11:00 a.m. each weekday. Any cases currently set for 9:30 a.m. or 12:00 p.m. will be heard as scheduled.

Traffic Courtroom C:

Effective December 1, 2021, first appearance\ determination of counsel hearings set for Traffic Courtroom C will move from 8:30 a.m. to 8:00 a.m.

PRACTICE TIPS FROM THE CIRCUIT COURT

LEGISLATIVE UPDATE, PLUS TIPS ON SHOW CAUSE AND JUDICIAL SETTLEMENT CONFERENCE REFERRAL ORDERS

There were a multitude of legislative changes during the recent regular and special sessions of the General Assembly. You may have heard of many of them, as some received widespread attention and publicity. The following are a few changes that may not have received as much attention; all changes can be reviewed at <http://leg1.state.va.us/> before July 1, and at <https://law.lis.virginia.gov/vacode/> after that date:

Changes to 20-60.3 support notices

Amendments changed these notices effective Jan. 1, 2021, and more changes will go into effect July 1, 2021. The easiest and best approach is to go to the websites above and block copy the new notices, then paste them into your orders. Orders that do not use the current notices will be returned for corrections.

Corroborating witness requirement eliminated for no fault divorces

If you are seeking to have a divorce granted on no fault (six months or one year separation grounds), and you submit affidavits or have a hearing after July 1, 2021, a corroborating witness will no longer be required. This is due to amendments to §§ 20-99 and 20-106.

Discovery rule for accrual of limitations for latent injury from exposure to a substance/use of a product

Virginia is slowly adding more “discovery rule” provisions for determining accrual of statutes of limitation. Effective July 1, if someone is injured by exposure to a substance or use of a product, and the injury cannot be diagnosed during the limitations period because it is dormant or does not develop (“latent”), then the cause of action accrues “when the person knew or should have known of the injury and its causal connection to an injury-causing substance or product.” This change results from an amendment to § 8.01-249.

Elimination of requirement of investigation and report in certain adult adoptions

Section 63.2-1244 currently requires an investigation and report if an adult adoption is based upon the adoptee being 15 years younger than the petitioner. As of July 1, that requirement will no longer be in the statute. An investigation and report will not automatically be required in any adult adoption, although the court still has the discretionary power to order one.

Expansion of stepparent adoption provisions to include adoption by a person with a “legitimate interest”

Section 63.2-1241 has been amended to add in the definition of a person with a “legitimate interest” from statutes governing custody disputes, and to give such persons the right to jointly petition for a stepparent adoption. Traditionally, two people could not join together in an adoption petition in Virginia unless they were married. That approach was first loosened with the enactment of § 63.2-1201.1, and will fall away further when the amendments to § 63.2-1241 go into effect July 1.

TIPS FOR SHOW CAUSE AND JUDICIAL SETTLEMENT CONFERENCE REFERRAL ORDERS

In recent months, there has been a new phenomenon of orders submitted for show cause for contempt ordering the alleged contemnor to appear “on a date to be agreed to between counsel.” This is not proper, as show cause orders must contain a specified date and time for the return date. In order for the court to have the power to punish a party for contempt who fails to appear, that person must have been served with an order telling them a specific date and time to appear. As a result, it is ineffective to enter an order that states the return date is essentially to be determined. Also, the return date and time should not be left blank – counsel needs to fill that in.

As a reminder, petitions for show cause must be sworn to under oath by one with personal knowledge. This has always been required, and several years ago was statutorily clarified by the enactment of § 8.01-274.1.

As for judicial settlement conference referral orders, counsel need to use the form order on the court’s web site. It is PDF-fillable, does not require counsel’s signature, and can be faxed in. This is required for proper processing by the court, and to prevent the inclusion and potential dissemination of personal contact information for the judge presiding over the conference once the order is entered and processed.
