### Speaker Biographies

## The Hon. Winship C. Tower (ret.)

Judge Tower presided over the City of Virginia Beach Juvenile and Domestic Relations Court from 2000-2016, and was its acting Chief Judge from 2008 to 2010. Judge Tower, a certified mediator by the Virginia Supreme Court, is now with the McCammon Group, specializing in alternative dispute resolution and mediation involving family and business matters; equitable distribution; business, retirement, deferred compensation, stock options and real estate valuations, divisions and dissolution; property tracing; tax issues; income analysis; alimony; child support, custody, visitation and parenting plans; pre and post nuptial agreements; elder law issues, legal malpractice, construction and contracts. Prior to taking the bench, she was a former Partner and Past Chair of Family Law Practice Group with Kaufman & Canoles, P.C. Judge Tower is a Fellow with the American Academy of Matrimonial Lawyers, the Virginia Law Foundation, and is a member of The Boyd-Graves Conference. She was a past member in the l'Anson-Hoffman Inn of Court, past chair, for the Board of Governors, Family Law Section of the Virginia State Bar, and a former member of the Board of Governors, Education of Lawyers Section and General Practice Section, for the Virginia State Bar. Judge Tower has served as Past Chair for the Domestic Relations Section; Member, the Commission on the Needs of Children and is a Former Member, the Commission on Professionalism, for the Virginia Bar Association. She was appointed by the Chief Justice of the Supreme Court of Virginia to serve on Advisory Committee on the Establishment of Family Law Courts in Virginia and the Futures Commission on Virginia Courts in the 21st Century, both in 2005. She is a past member of the Law Revision Committee of the Judicial Conference of Virginia for District Courts, a Former Member of the Liaison Committee for Juvenile and Domestic Relations District Courts, the Virginia Beach Bar Association, Former Co-Lead Judge, Juvenile Detention Alternative Initiative, Virginia Beach Juvenile and Domestic Relations District Court, and a Former Co-Lead Judge, Court Improvement Project, Virginia Beach Juvenile and Domestic Relations District Court. Judge Tower is a Frequent speaker at Continuing Legal Education and Judicial Education Programs on family law issues and complex financial issues in mediation. She was the 2000 Recipient of Women of Distinction Award from YMCA of South Hampton Roads, and named among "Influential Women of Virginia" by Virginia Lawyers Weekly, in 2011. Judge Tower received her BA with Honors from Rollins University and her JD from the University of Virginia School of Law.

## The Hon. Adrianne Bennett

Judge Bennett was appointed to the Virginia Beach Juvenile and Domestic Relations Court in April of 2020. Prior to that she served a long tenure with the Virginia Parole Board, where she was appointed in 2004, and became its Chairwoman in 2017. Prior to serving on the parole board, Judge Bennett was a lawyer in private practice focusing on criminal defense, juvenile, and family law.

## The Hon. Tanya J. Bullock

Judge Bullock currently serves as a presiding Judge of the Virginia Beach Juvenile and Domestic Relations District Court. She is a native of Virginia Beach, Virginia. She is a graduate of North Carolina State University and received her Juris Doctor degree from Regent University School of law in 2000. In 2016 Judge Bullock received an Executive Certificate in Multi-System Integration from Georgetown University's Center for Juvenile Justice Reform. After graduating from law school, Judge Bullock worked as a prosecutor in the Norfolk and Virginia Beach Commonwealth Attorney's Offices. Subsequently, she entered into private practice and started her own law firm, Bullock & Cooper, with her identical twin sister, Wanda Cooper. As a practicing attorney, her primary practice areas were criminal defense and federal civil litigation. Judge Bullock developed a niche in litigating what had become known as foreclosure rescue scams. In fact, she was at the forefront of getting Virginia's first foreclosure rescue scam statute passed in 2008. Judge Bullock and her firm received numerous honors and awards. She was named Judge of the Year by Regent University School of Law in 2019, was given an Outstanding Service Award from the Association of District Court Judges, received the Hampton Road's "Top 40 Under 40" Award by Inside Business, the Partners in Education Award from the Virginia Beach Public School System, the Urban League Silver Star Legacy Award, Outstanding Professional Woman Award and her firm was named, Virginia Beach's Business of the Year by the Department of Economic Development in 2011. Integrally involved in her community, Judge Bullock is a member of Alpha Kappa Alpha Sorority, Inc. and is an adjunct professor at Norfolk State University. She has served on the Virginia Board of Correctional Education, the Virginia Beach Community Development Corporation which focused on providing workforce housing and was a member of the Virginia State Bar Association's Disciplinary Committee. In addition, she is a proud graduate of the CIVIC Leadership Institute. In her spare time, Judge Bullock often can be found coaching recreational cheerleading, serving as a team mom for soccer and cheerleading or at the gym. She also enjoys competitive bodybuilding. In 2012, Judge Bullock was appointed by the Governor as a judge to the Virginia Beach Juvenile and Domestic Relations District Court. She presides over criminal and civil cases involving juveniles, adults involved in disputes concerning support, custody, visitation, foster care and protective order cases. She is currently the Second Vice President of the Association of District Court Judges, a member of the Virginia Council of Juvenile and Domestic Relations District Court Judges and was appointed by the Chief Justice of the Virginia Supreme Court as a member of the Committee on District Courts. She serves on the District Courts Technology Committee, Forms Committee, is the Chair of the Judicial Liaison Committee for the Department of Juvenile Justice and serves as a Judicial Mentor. She is a member of the National Bar Association's Judicial Council and the Virginia State Bar's Judicial Division.

## The Hon. Deborah V. Bryan

Judge Deborah V. Bryan is a Juvenile and Domestic Relations District Court judge in the Second Judicial District, City of Virginia Beach, Virginia and was elected to the bench in 2004. After graduating *magna cum laude* from Virginia Tech in 1979 and a career as a contracting officer for the U.S. Navy and in the private sector, she undertook the Virginia Study Under An Attorney (Law Reading) Program, completed it in 1995 and was admitted to the Virginia Bar that year. Prior to her election to the Virginia Beach Juvenile and Domestic Relations District Court bench in 2004, Judge

Bryan's law practice included an emphasis on domestic relations and representation of children as a Guardian Ad Litem. Judge Bryan serves as an ex officio judicial member of the Board of Governors of the Family Law Section of the Virginia State Bar. She also serves on the Supreme Court's Access to Justice Commission and is the Chair of the Committee on Access for Self-Represented Litigants for that Commission, on the Supreme Court of Virginia's Advisory Committee on Rules of Court, and has previously served two terms on the Judicial Council of Virginia. She has completed terms on the Executive Committee of the Judicial Conference of Virginia for District Courts and the District Court Forms Advisory Committee, and has served as a Mentor for the Supreme Court of Virginia's Mentoring Program for New Judges. She is a past President and Vice President of the Virginia Council of JDR Judges and serves on its Judicial Support Committee and previously as liaison to the Judicial Council. She has served a two-year term as Chief Judge of the Virginia Beach J&DR Court, as a lead judge for Va. Beach J&DR District Court's Court Improvement Committee and a lead judge for the Virginia Beach J&DR Court's Juvenile Detention Alternatives Initiative program. She has been appointed by the Governor of Virginia to the Child Support Guidelines Review Panel for two terms and currently serves on that Panel. She is currently a member of the National Council of Juvenile and Family Court Judges, and has served on its Military Issues Committee. Judge Bryan has appeared as a speaker and panel member for various judicial and bench/bar conferences, and has provided judicial pre-bench training for new J&DR judges in the areas of custody, visitation and support.

# The Hon. Cheshire l'Anson Eveleigh

Judge Eveleigh was appointed to the Virginia Beach Juvenile and Domestic Relations Court in March of 2019. Prior to taking the bench, Judge Eveleigh was with Wolcott Rivers Gates for 29 years, where she was a partner practicing in family law, civil litigation, alternative dispute resolution, and appellate advocacy. Judge Eveleigh was the Chair of the Virginia Family Law Coalition and worked heavily with the General Assembly on family law legislation involving custody and related matters. She was the 2017 recipient of the Virginia State Bar's Family Law Service Award. She received her bachelor's from Oral Robert's University and her JD from the College of William and Mark School of Law. Judge Eveleigh was also the past secretary of the Virginia Chapter of American Academy of Matrimonial Lawyers, a diplomate in America College of Family Law Trial Lawyers, the past president of the Norfolk Portsmouth Bar Association, past chair of the Domestic Relations Council of the Virginia Bar Association, past chair of the Family Law Section of the Virginia State Bar, and past president of the Family Law Organization of Greater Hampton Roads.

## The Hon.Timothy J. Quick

The Hon. Timothy J. Quick began his legal career in 1994 as an Assistant Commonwealth Attorney for the City of Virginia Beach, and last served on the juvenile court team before entering private practice. in December 1999, he joined the law firm of Kalbaugh, Pfund, and Messersmith, where he practiced primarily insurance defense for three years. In 2003, he opened his own practice and litigated in every court in Hampton Roads. In 2008, Judge Quick was selected as the Deputy Capital Defender for Southeastern Virginia, and briefly served as the Acting Capital Defender before returning to private practice in 2010. He served as the president of the Virginia Beach Bar

Association in 2011. Judge Quick was appointed to the Virginia Beach Juvenile and Domestic Relations District Court and took the bench in April of 2019.

# Christianna Dougherty-Cunningham, Associate City Attorney- City of Virginia Beach

Ms. Cunningham is an Associate City Attorney with the City of Virginia Beach and has been with the City since 2004. She is currently assigned to the human services section handling the child welfare dockets, adult protective services, quardian and conservatorships, mental health and crisis services, behavioral health and developmental services, and human services protected information.
