It is my pleasure to hereby nominate Deputy City Attorney Christopher S. Boynton for Circuit Court judge and General District Court judge for the City of Virginia Beach.

Mr. Boynton, who lives in the City of Virginia Beach, was born in Williamsburg, Virginia on October 9, 1970. He received his B.A. in Economics with a minor in Government from the University of Virginia in 1992, where he was an Echols Scholar and a Virginia Scholar. Mr. Boynton received his law degree in 1995 from the Marshall-Wythe School of Law at the College of William & Mary, where he was a Goodwin Scholar. He was admitted to the Virginia State Bar, the Supreme Court of Virginia, the U.S. District Court for the Eastern District of Virginia, the U.S. Court of Appeals for the Fourth Circuit, and the U.S. Bankruptcy Court for the Eastern District of Virginia in 1995. He was admitted to practice before the Supreme Court of the United States in 2007.

Mr. Boynton has 27 years of active trial practice. He has been a civil trial attorney with the Virginia Beach City Attorney's office since 2000 and was previously a litigation attorney with Cooper, Spong & Davis, P.C. from 1995-2000.

Since 2009, Mr. Boynton has served as Deputy City Attorney for Litigation where he is presently responsible for all civil litigation involving the City of Virginia Beach and its employees. He has eight attorney direct reports, all while maintaining an active trial practice. His practice currently involves handling the City's highest profile and most difficult cases, mostly in Virginia Beach Circuit Court and the Eastern District of Virginia federal court. Those cases include complex personal injury and Section 1983 police excessive force cases, civil rights litigation, employment litigation, commercial litigation including construction, real property, development, and land use disputes, and enforcement and defense of municipal ordinances and authority.

As part of his service with the City Attorney's office, for several years Mr. Boynton prosecuted DUI and other traffic and criminal misdemeanor cases in Virginia Beach Circuit and General District courts. During his time with Cooper, Spong & Davis, Mr. Boynton represented plaintiffs in personal injury cases and defendants in misdemeanor criminal and traffic cases in circuit and general district courts throughout Hampton Roads.

In all areas of practice, Mr. Boynton has demonstrated a strong ability to distill and analyze complicated factual scenarios, identify and assess legal issues, apply applicable law to pertinent facts, and reach well-reasoned and often insightful conclusions. He is a skilled oral advocate, perceptive, quick-witted, and articulate. Importantly, he also has the common sense, balanced temperament, calm demeanor, humility, and personal skills necessary to make a fine jurist.

Mr. Boynton has been an AV-rated attorney by Martindale-Hubbell continuously since 2013. He is a recent Past President (2018) of the Virginia Beach Bar Association, having served on its Executive Board from 2013-2019. He is a long-time active member of the Virginia Beach Bar Association, having earlier served as Chair of its Circuit Court Liaison and Membership committees. Mr. Boynton is also a Past President (2012-13) of the James Kent American Inn of Court, and a recent Past Chair (2017-18) of the Virginia State Bar's Construction Law and Public Contracts Section Board of Governors. He presently serves on the Board of Directors for the Virginia Beach Bar Foundation.

In addition to his service with various bar organizations, Mr. Boynton's service to our community includes six years on the Board of Directors for Tidewater Community College, with two years as its Vice Chair from 2000-2002. Mr. Boynton served as President of the University of Virginia Club of Tidewater from 2006-07 and served on its board for many years. Mr. Boynton is a 1999 alumnus of Leadership Hampton Roads, and served on the Board of Directors for the Hampton Roads Chamber of Commerce (Portsmouth Division) in 2000.

Mr. Boynton has not been publicly reprimanded nor has his license to practice law ever been suspended or revoked by the VSB Ethics Committee or similar bar agencies elsewhere. He is intelligent, hardworking, experienced, organized, and energetic. He is of the highest moral and ethical character and is highly respected by his colleagues and peers. I believe Christopher Boynton has the experience, education, skill, character, demeanor and temperament to be an excellent Circuit Court or General District Court judge, and I highly recommend his selection.
