Dear Mr. Booth.

It is my honor to nominate Christianna Dougherty-Cunningham as a candidate for a vacancy on the Virginia Beach Juvenile and Domestic Relations Court Bench should one become available during the coming session. Ms. Cunningham has been an attorney in the City Attorney's Office since March 2004, coming to the office after almost five years of private practice. Her work with the office has demonstrated that she is a dedicated and driven individual who is trustworthy, steadfast, and a true teamplayer. In her eighteen years with our office, she has handled almost every type of municipal litigation, often taking on new subject matters with little assistance. She has been a trusted member of our litigation team, starting off her career with the City handling civil litigation assignments and eminent domain matters. She quickly was handling both bench and jury trials. In approximately 2008, our office's social services department found itself unexpectedly without counsel and Ms. Cunningham and two of her colleagues stepped in to assist. Although up to that point, her experience with the Juvenile and Domestic Relations Court had been limited to custody and visitation cases in private practice, Ms. Cunningham spent hours learning child welfare law and quickly became more than proficient such that she assisted in establishing new office procedures for making the child dependency dockets run more efficiently.

Ms. Cunningham has always been one of those individuals willing to step in and help wherever and whenever anyone needs assistance. She is always available for her clients and colleagues to listen and work through problems to find the right outcome. Of late, she has been integral part in trying to mitigate challenges faced by Virginia Beach citizens who must navigate the mental health system in Virginia. She has also been a prominent voice at the table in the implementation of the statewide Virginia Department of Social Services Performance Improvement Program that came as a result of the Federal Child and Family Services Review and the 2017 Virginia Joint Legislative Audit and Review Commission's study into child welfare practices across the state.

While carrying a full docket and managing multiple committee assignments with various state and local workgroups focusing on juvenile law, child welfare, and mental health issues, Ms. Cunningham devotes most of her personal time to activities that further the legal profession. She has been a grader for the Virginia State Bar for over fifteen years and has served on the Virginia Beach Bar Association Juvenile and Domestic Relations Court Committee for over ten years, acting as Committee Chair since 2017. Her tireless work with the Virginia Beach Bar Association and development of annual day-long continuing legal education seminars that involve the bar and bench, and typically fulfill most of the

required credits for both the Guardian ad Litem Certification and the Indigent Defense Commission, recently earned her the 2021 Virginia Beach Bar Association Service Award. Ms. Cunningham has also been an active member of the James Kent American Inn of Court and served as its president from 2019-2020. While working with the Inn, she has mentored numerous law students and newly licensed lawyers in an effort to ensure the proliferation of civility and ethics within the profession. Ms. Cunningham also routinely serves as a moot court and mock trial judge for both the College of William & Mary and Regent University and has published for the latter.

The subject matter over which the Juvenile and Domestic Relations Court presides is broad, and the parties that come before the Court often include the most vulnerable individuals in our community. The cases often involve extremely sensitive facts and on occasion, simultaneous civil and criminal matters arising from the same events are active on the docket, posing unique constitutional and statutory issues for the Court to properly navigate. It is these unique cases where Ms. Cunningham excels; she does not shy from complexity and brings a calm yet probing perspective to ascertain the correct answer within the boundaries of the law. She routinely lends her expertise to various local and statewide workgroups focusing on child welfare, juvenile detention alternatives, mental health, and racial and ethnic disparity issues, and has devoted a significant period of time working with the Virginia Department of Social Services and the Court Improvement Program through the Office of the Executive Secretary in the statewide implementation of the federally required Performance Improvement Plan.

Ms. Cunningham also brings a perspective to the local bench shared by many of the citizens who come before our Virginia Beach Courts, namely she is not a native Virginian. Born and raised in St. Louis, Missouri, Ms. Cunningham attended Arizona State University, graduating in 1995 with a Bachelor of Arts in Broadcasting. She worked in Phoenix radio for a year before returning home to St. Louis for law school. After graduating from St. Louis University School of Law in 1999, she relocated to Virginia Beach with her then soon to be husband, Mark "McKay" Cunningham, who had taken a job with a local radio station. The Cunninghams now consider Virginia Beach their hometown and have been active in the community for the past 23 years.

Ms. Cunningham has dedicated the majority of her career to public service. That said, she did start out her career with the Norfolk based firm of Tayss Fletcher, and thus she has an appreciation for the private bar. Ms. Cunningham has no disciplinary history, and it is clear from her demonstrated work ethic and determined involvement in related activities that her work is not merely a job, it is a passion. Ms. Cunningham will undoubtedly bring the same passion to the Virginia Beach Juvenile and Domestic Relations Bench. This passion will certainly be a benefit to those families, children, and persons coming before the Court, often at the worst times in their life, when they need to be heard, and when they need to access justice in an efficient, yet thorough and patient manner.

Again, I am honored to nominate Ms. Cunningham as I believe she would make an excellent member of the Juvenile and Domestic Relations Court bench and I request your thoughtful consideration of her candidacy should one become available during this term.
